

IMSA Makey Lab STEM Camp Waiver

By execution of this release form, I agree that all requirements, directions and standards set by staff, use of any equipment or supplies under the supervision of the staff, shall be deemed to have been accomplished for the benefit of my child. In the consideration of Kidzeum's efforts on my child's behalf, I do hereby voluntarily assume all risk of accident, injury, damage and/or loss to my child's property that may arise out of my child's participation in the IMSA Makey Lab STEM Camp at Kidzeum, hereby intending to release and discharge the Illinois Math and Science Academy (IMSA) and Kidzeum of Health & Science, their Board of Directors, officers, employees and agents associated or connected with the IMSA Makey Lab STEM Camp from every claim, liability or damage of any kind caused by negligence of IMSA, Kidzeum of Health & Science, their Board of Directors, officers, employees or agents involved or otherwise that may result from my child's participation in the IMSA Makey Lab STEM Camp. The undersigned acknowledges that the child named is a minor under the age of 18. Although a minor, my child is aware of the risks involved with participating in the IMSA Makey Lab STEM Camp. I assure IMSA and Kidzeum of Health & Science that I have carefully counseled my child on the risk of participating. Further, I assure IMSA and Kidzeum of Health & Science that there are no physical or other reasons that preclude my child from participating in the IMSA Makey Lab STEM Camp. I authorize Kidzeum of Health & Science to obtain such medical care, emergency or otherwise, that it may in its sole discretion deem necessary for my child. Further, I assure IMSA and Kidzeum of Health & Science that I have adequate health insurance or personal funds to provide payment for all costs of medical care necessary for my child. I agree to indemnify and hold harmless IMSA and Kidzeum of Health & Science for any costs associated with such care. Kidzeum staff reserves the right to dismiss students from classes for disciplinary reasons. All students are expected to behave in a positive and productive manner. Parents will be notified if inappropriate behavior is observed and documented. Should behavior continue, students will be dismissed from the program. Under those circumstances, no refunds will be given. The camp will run from 8:30am to 3:00pm each day. I understand that I will be charged an additional \$1 per minute, beginning at 3:00pm, if my child(ren) are not picked up by the designated time.

Additionally, Kidzeum of Health and Science and IMSA have my permission to use my or my child's photograph or video for public promotions. I understand that the images or video may be used in print publications, online publications, presentations, websites, and digital/social media. I also understand that no royalty, fee or other compensation shall become payable to me by reason of such use.
