

IMSA Makey Lab STEM Camp Waiver

Welcome to the IMSA Makey Lab STEM Camp online program through Kidzeum! We will be using Zoom, an online video conferencing service to bring you our program and interact with participants. This will be a fun and engaging time for your student and our instructors!

Before we get started, we need to remind parents and guardians that students will be on a live video conference that may be recorded. Please read through the following guidelines so we can maintain a safe experience for all participants.

1. We will send you a link to join the Zoom class meeting. You will NOT need to set up a Zoom account or input any information except for the student's first name and last initial.
2. The meeting will be live and interactive. Please make sure your student is in a quiet place where a parent can monitor the session if they would like. Please remember that everything within the camera viewing area will be visible to the teacher and other students. Please be aware that there may be online media that contain references, ads, or links to material from third parties. IMSA and Kidzeum are not associated with those third parties.
3. Sounds and voices can be captured by your device's microphone and heard by others in the Zoom session. Teachers will mute participants for portions of the session and may unmute participants during discussion or to hear questions.
4. During live sessions, participants may hear and see anything within the audio and camera viewing areas. Please make household members aware of this.
5. These sessions will be recorded for viewing by students who were unable to attend that session or for the attending students to review the materials again if needed. Students will only be identified by their first name.
6. Please discuss responsible and appropriate behavioral expectations with your student that may be applicable online. We will also monitor the students and set virtual classroom expectations so that all who participate will have a safe and fun learning experience together.

Refund Policy:

Please choose your programs carefully. Refunds of 50% of the tuition will be honored through June 30. No refunds whatsoever will be granted after July 1. Requests for tuition refunds must be made in writing by sending an email to info@kidzeum.org Please include the program name and date, your child's name, and your name. Phone call requests for refunds will not be accepted.

Program Cancellation:

If insufficient students register for a program, Kidzeum and IMSA reserve the right to cancel that program. Participants will be notified at least one week prior to the start date and a full refund will be given. If space allows, you may elect to apply previous paid fees as credit toward another IMSA Makey Lab STEM Camp session at Kidzeum.

Behavior and Discipline:

Kidzeum and IMSA encourage the highest standards of conduct, civility, and a sense of fair play as is consistent with the student standards of behavior at Kidzeum and IMSA. Students enrolled in the IMSA Makey Lab STEM Camp are expected to be polite to their fellow campers and instructors and to follow the rules and expectations of the virtual program. Kidzeum and IMSA reserve the right, in their sole discretion, to deny any camper the opportunity to participate in camp if the student’s conduct or behavior is deemed unsatisfactory by the camp administration or detracts from the other campers’ experience.
